Organizations that provide EB-5-related services, i.e. attorneys, broker/dealers, consultants, real estate developers, economists, financial advisors, project managers, or other U.S.-based EB-5 service providers.

Introductory Rate: \$1,500 | Annual Renewal: \$3,000

INTERNATIONAL STAKEHOLDER MEMBER:

EB-5 service providers with primary business operations based outside the United States, including migration agents, financial consultants, foreign immigration specialists, and other professionals who help assist committed investors navigate the EB-5 process.

Introductory Rate: \$500 | Annual Renewal: \$1,000

ALLIED PARTNER MEMBER:

For-profit, non-profit, and government entities that benefit from EB-5 economic development, investment, and job creation including economic development organizations (EDOs), chambers of commerce, municipalities, restaurants, hotels, retail businesses, schools and universities, and health care organizations.
