## AN ACT

To extend by 3 years the authorization of the EB-5 Regional Center Program, the E-Verify Program, the Special Immigrant Nonminister Religious Worker Program, and the Conrad State 30 J-1 Visa Waiver Program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REAUTHORIZATION OF EB-5 REGIONAL CEN-**  
2 **TER PROGRAM.**

4 tice, and State, the Judiciary, and Related Agencies Ap-  
5 propriations Act, 1993 (8 U.S.C. 1153 note) is amend-  
6 ed—

7 (1) by striking “pilot” each place such term ap-  
8 pears; and

9 (2) in subsection (b), by striking “September  
10 30, 2012” and inserting “September 30, 2015”.

11 **SEC. 2. REAUTHORIZATION OF E-VERIFY.**

12 Section 401(b) of the Illegal Immigration Reform and  
13 Immigrant Responsibility Act of 1996 (8 U.S.C. 1324a  
14 note) is amended by striking “September 30, 2012” and
