- ★ Represent Regional Centers and facilitate their efforts in addressing administrative, regulatory and legislative issues at all levels of government.

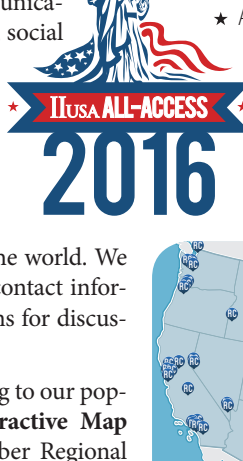
