EB-5' Economic Impact Around the U.S.

IIUSA developed a method to estimate the economic benefits and job creation contributions of all Regional Center projects that were active during federal fiscal years 2014 & 2015 across the entire U.S. economy. The data below is referenced from the *IIUSA Economic Impact Report, 2019* peer-reviewed study"



\$23.2+ billion

EB-5 investment and Regional Center projects contributed more than \$23.2 billion in labor income for U.S. workers (wages, salaries and proprietors' income).



\$10.8 billion

in capital investment was made through EB-5 Regional Centers.



16 jobs

On average, Regional Center projects supported more than 16 American jobs for each of the foreign investors invested through the EB-5 Program.



\$55.5 billion

EB-5 investment and Regional Center projects contributed nearly \$55.5 billion in the U.S. economy in terms of Gross Domestic Product (GDP).
